



GENERAL ASSEMBLY MEETING
January 21, 2015

The meeting was called to order at 3:35 p.m. by Jennifer Clark, President.

Roll Call: Roll was taken via sign-in sixty-nine members were present for General Assembly meeting.

Minutes: The minutes for November excluded a committee report so they will be reviewed next month.

OLD BUSINESS: Cori Purdue moved to approve the amendment to the bylaws presented at the November meeting, Article III Organization, Section 3 Representation, B – Each organizational unit of the University employing at least one eligible professional staff member shall be entitled to one representative for each fifteen member, or fraction thereof, as determined by the Assembly Nominations and Elections committee prior to any notice seeking nominations, except for the first year when the apportionment is approved by the Professional Staff Constitutional Conventions.

The PSA currently has 114 representative seats, after the next election with the current ratios there will be 125. Each year, the number of PSA seats is recalculated based on current Professional Staff numbers in each unit. The PSA has not made any changes to this ratio since the bylaws were written in 2005, despite a staggering amount of growth at the University.

Jennifer opened the floor for discussion, the following concerns/questions were discussed by the Assembly:

- Amy Rogers, CCHS -Have all areas been made aware of this change? Yes, we brought the changes of the amendment to the floor during the November GA meeting and all members were sent a copy of the minutes from that meeting.
- Julie Elmore, Financial Affairs- In agreement with the changes, because your representatives should be sharing the information from the PSA meetings in their areas.
- Tyna Kozak, Student Affairs – All PSA meetings are open all professional staff, you don't have to be an elected member to attend.

- Robert Baxter, Financial Affairs - it appears that since April we have been making quorum, so not sure that matters.
- Jackie Northrup, Student Affairs – with the change of the amendment large groups may be under represented. If you miss 4 meetings you could be removed, doesn't that help with the quorum? You can be removed if you miss 4 meetings. PSA never turns down members, if a seat is open then someone can be appointed to that seat in an at large position.
- Cori Purdue, Academic Affairs – Do we calculate the quorum based on open seats? No, quorum is calculated by the number of filled seats.
